If anyone requires any printed details which have been emailed to them or are on the website, please let me know and I will provide these for you at my earliest opportunity before the meeting.

If you feel you would benefit from a tutorial in logging into and using either the parish council website as a Councillor rather than just as a member of the public, please let me know and I can run through this with you.

Notes on Agenda items

- 1901 The Chairman will explain to everyone how the meeting will be carried out in line with the council's meeting policy.
- 1905 Members are reminded that [Standing Order](#) 12 discusses draft Minutes. Should anyone have any comments on the Minutes, including minor amendments such as spelling errors, punctuation or grammar, these should be notified to the Clerk at the earliest opportunity, in advance of the meeting date, so as not to take unnecessary time in the meeting.
- 1910 As always, in line with the law laid out in the Local Government Act 1972 and its amendment in 2000, **any issue that is not described in the agenda cannot be raised and no decisions can be made or acted upon by the Council.** This includes if parishioners contact Parish Councillors and ask them to discuss something at the parish council meeting. Parish Councillors are legally not permitted to raise items under parishioners' time and must request the Clerk adds items to the agenda for discussion. So, if you do have something you would like to raise at the meeting, please contact a Parish Councillor or the Clerk at least 4 clear days (not including weekends, or Bank Holidays) before the meeting, to ensure the item can be added to the agenda for discussion.
- 1925i&ii Copies of Cllr Wright's reports will be posted on the website with the agenda for the meeting.
- 1925iii Members will note the update from Blaby DC on gas extractions around the site.
- 1925iv An update on recent crime statistics around the parish will be provided at the meeting.
- 1955i Reports will be considered from any community group in Huncote.
- 2000i Members will consider the quality of grass cutting on all public land in the village. A [map of all publicly owned sites](#), illustrating who owns what land is available via the parish council website and toggling the layers.
- 2000ii Members will review details of any issues affecting public sites around the village.
- 2005ii Members will review the 80th Anniversary of D-Day commemoration event (Thurs 6th June 2024).
- 2010i Members will be updated on the removal of the ducting and telephone/internet wiring from the park which was installed without authorization on parish council land.
- 2010ii Members will review the analysis of speed data on Main Street and Narborough Road. ***
It is hoped an update will be available from County Highways on timescales for installing the new MVAS post on Forest Road.
- 2010ii Members will review details of any issues affecting highways and footpaths around the village, for passing comment to County Highways, as the relevant authority to deal with.
- 2020i Members are asked to consider any grant applications received before the meeting.
- 2020ii Details of Annual Accounts and Governance Statement will be circulated to Members once returned from internal audit.
- 2020iii Details of the Accounting Statement will be circulated to Members once returned from our internal auditor. Details of this will be posted on the notice boards during a period of full public consultation, as standard for every year.
- 2020iv Members are advised that The Co-operative Bank and Coventry Building Society signed a share purchase agreement under which the Society will acquire the entire issued share capital of the Bank. The acquisition is subject to the satisfaction of certain conditions and approval from both the PRA and FCA. The acquisition is expected to complete in the first quarter of 2025, and the Bank will continue to operate as a separate business for some time after completion.
The Co-operative Bank state there is no impact to their bank products or services and no changes to FSCS deposit protections.
- 2020v Details of any known increases in subscription charges notified since the last meeting will be brought to Members' attention.
- 2040i Members are asked to review all new planning applications and provide a view, for Council comment.
- 2040ii The Council will be advised of any new planning enforcement issues in the parish.
- 2040iii The Council will be advised of the results of any planning applications affecting the parish from the relevant planning authority.
- 2040iv Following a meeting with developers, and public consultation at the end of 2023, Members are asked to consider the requirements for how they envisage a new community facility being used, and what requirements it will have and consider any other information discovered during the meeting.
- 2040v Updates will be provided on major local projects.
- 2040v Members can raise any issue of planning concern during this item which can then be passed to the Planning Enforcement team at the relevant Planning Authority to review.
- 2050 Members will review any quarry reports received before the meeting.
- 2055i-iii Members will receive an update on current pr and consider any issues.

2055iv Members will note a recent request from Huncote Primary School to update the name of the Community Centre to Huncote Primary School Hall, and consider any implications.

2105 Members will be asked to provide an opinion on current consultations.

2110 The Clerk will provide an update on any relevant issues.
