Minutes of meeting held at 7:00 pm on Thursday 13th June 2024

at St James the Greater Church Hall, Narborough Road, Huncote, Leicester LE9 3AW

8962 **To receive apologies for absence** Apologies had been received from Cllr R. Bailey (partner unwell), Cllr J. Cheesman (work) and Cllr K. Clarke (running late) which were accepted.

8963 Chairman's opening remarks and Member introductions

The Chairman welcomed everyone to the meeting, explained meeting procedures and noted a large planning application had been received following the publication of the agenda for 154 houses south of Ratcliffe Drive, Peers Way and Preston Way. As this was a larger application, a special meeting was being arranged for Tuesday 18 June to review the application before the 2 July deadline. The Chairman also noted a parishioner had shown interest in being co-opted so was observing the meeting.

The Clerk explained details of which public land in the village was managed by which organisation was shown on a map on the parish council website.

RESOLVED: Members noted the weather had been an issue for mowing, but recent cuts from the County Council could have been better. Concerns were also raised about weeds in the gutters which had been in place since before COVID-19, impacting the long-term structure of the roads around the village and county.

RESOLVED: Members noted the fish and chip samplers had noticeably been enjoyed by many village children. The Beacon lighting event with HATS performance had been attended by 150-180 people. While HATS had provided their own PA system, when Councillors read their readings, they had chosen not to use the PA system and stood near the beacon, which meant they couldn't all be heard so well.


