

As you will soon be putting the Christmas tree up in your houses (if you haven't already), we would like to remind you not to leave presents under the tree, where they can be seen from the front window, as burglars love window shopping. Remember to keep your doors and windows locked, to prevent possible burglaries and the loss of any treasured items which might have been received or are intended to be gifted for Christmas. You're far better to be safe than sorry. In the run up to Christmas when you will be out Christmas shopping please be extra vigilant and leave shopping out

of sight in the boot of your car with the receipts removed from bags. Remember: if you leave it on show – expect it to go!

locked when you leave it and whenever possible parked with the back doors up to a wall. Post coding your power tools and equipment also acts as a deterrent.



Never click on a link received via a text about a delivery, this could be a scam. Stop and think, you shouldn't have to pay a fee for a missed delivery. If you're unsure and you think you have a package arriving, remain vigilant and check delivery notifications very carefully to ensure they are

I wonder if you can remember any gift that you were given last Christmas? I can remember one or two but not all of them.

Parish Councillor vacancy

Huncote Parish Council currently has a vacancy for a Parish Councillor following the resignation of Cllr Liam McEntee.

We would like to thank Mr McEntee for his contributions to the Council over his 5 years as a Parish Councillor.

Parish Councillors are both elected and/or co-opted to the council to represent the interests and expectations of all parishioners who live and work within the Huncote parish boundary. Parish Councillors have three main components to their role.

Decision Making –

Through meetings and attending committees with other elected members, councillors decide which activities to support, where money should be spent, what services should be delivered and what policies should be implemented.

Monitoring – Councillors make sure that their decisions lead to efficient and effective services by keeping an eye on how well things are working.

Getting involved locally - as local representatives, Councillors have responsibilities towards their parishioners and local organisations. These responsibilities and duties often depend on what the Councillor wants to achieve and how much time is available, and may include:

- Attending meetings of local organisations
- Attending meetings of bodies affecting the wider community
- Taking up issues on behalf of members of the public
- Running a surgery for residents to bring up issues
- Working with other organisations to deal with local issues and concerns

Households urged to check eligibility for winter support schemes

From 1 November, households in England and Wales receiving certain benefits including Pension Credit could be eligible for extra money to help keep warm during the cold weather until the end of March 2025.

The Department for Work and Pensions' Cold Weather Payments are an automatic bank top-up of £25, triggered to be paid to eligible households when the average temperature has been recorded as, or is forecast to be, zero degrees Celsius or below for seven consecutive days at the weather station linked to an eligible person's postcode.

The £25 payments will be paid automatically to households receiving certain benefits including, Pension Credit, Income Support, income-based Jobseeker's Allowance (JSA), income-related Employment and Support Allowance (ESA), Universal Credit and Support for Mortgage Interest. Hinckley National Rail Freight Interchange decision delayed into new year - Respond now

There is still time for Interested Parties to comment on the additional information requested from the Applicant by the Secretary of State for Transport on the development consent order for the HNRFI proposals.

The Secretary of \State has explained she has extended the statutory decision deadline for her formal response until 10 March 2025, as she is presently minded to refuse the application, but has given the developers until 10 December 2024 to provide answers to various questions and enable them to provide more information on the project. Anyone can then review the documents on the Government's



National Infrastructure Project Planning website (https://national-infrastructure-consenting.planninginspectorate.gov.uk/projects/TR050007) and those registered as an interested party in the development can respond before the revised deadline of **31 January 2025**.

Don't forget to submit Self Assessment tax returns

HM Revenue and Customs (HMRC) is <u>reminding anyone who needs to</u> <u>complete a Self Assessment tax return for the first time to cover the 2023 to 2024 tax year to do so.</u>

<u>Further information can be found on GOV.UK</u> and anyone who is unsure if they need to file Self Assessment can use the <u>free online tool on GOV.UK to check</u>.

HMRC has a wide range of resources to help customers register for Self Assessment, including <u>video tutorials on YouTube</u> and <u>help and support on GOV.UK.</u>

The deadlines for tax returns for the 2023 to 2024 tax year was 31 October for paper returns, although online returns can be submitted until 31 January.
